NFPA 1033 - Fire Investigator

Course fee: \$90.00 (+ symposium registration) **textbook you will need to purchase:**

IFSTA 1033 2nd edition

This course is online for 8 weeks and 3 days of in class and on the fire ground learning activities. It is a blended course and covers all investigative competencies associated with NFPA 1033, 2014 edition, including scientific method, Origin & Cause, building construction, scene safety, scene re-constructions. All aspects of assessing & investigating fires and adheres to NFPA 921.

This course will require students to be **FIRE OFFICERS** or **Firefighters with a minimum 5 years of firefighting experience, be a member of an Ontario Fire Department. 16 students max in this course**

NFPA 1041 – Fire Instructor 1

Course Fee \$90.00 (+symposium registration). **Textbook required for this course: IFSTA 1041 Fire Instructor 8th or 9th edition**

This course will take place both online for 8 weeks and in class and will teach students how to deliver training to a variety of audiences in an effective manner. Students will learn how to use a lesson plan effectively by analyzing and applying principles of adult education, assessing learner needs, planning lessons and conducting evaluations. Considerations for scheduling, learning environments and community stakeholders.

This course will require students to have 1001 and 5 years experience as a firefighter, be a member of an Ontario Fire Department. 14 students maximum in this course

NFPA 1035 – Fire & Life Safety Educator level 1

Course fee \$65.00 (+ symposium fee) **Textbook required for this course: IFSTA 1035 Fire & Life Safety Educator 3rd edition**

This course will be online for 8 weeks and finish with a day in class doing skills. It provides students with the skills necessary to deliver and coordinate existing fire & life safety education at various levels within a community. This course examines fire behaviour, human behaviour during a fire, educational methodology and basic fire protection systems. Scheduling of activities, recognizing opportunities for shared efforts with common fire & life safety goals, and adapting lesson plans to the needs of the audience.

This course will require students to be a member of an Ontario Fire Department, 16 students maximum for this course
